Special provision in the constitution were designed to secure equality of gender and nondiscrimination and they were-⁵

- Article 14- Equality before law and equal protection of law
- Article 15- State shall not discriminate against any citizens on ground only of religion, race, caste, sex, or place of birth and the state is permitted to make any provision for women and children
- Article 16- Equality of opportunity in public employment
- Article 39(a) Equal rights for men and women to adequate means of livelihood
- Article 42- Human condition of work and maternity relief of women
- Article 44- To secure for all citizens a uniform civil code throughout the country
- Article 51A (e) It is a constitutional duty of every citizen of India to renounce practices derogatory to the dignity of women
- Article 243D(3)- Not less than one-third of the total number of seats to be filled by direct elections in
 every panchayat to be reserved for women and such seats to be allotted rotation to different
 constituencies in a panchayat
- Article 243D (4) Not less than one-third of the total number of officers of chairpersons in the panchayats at each levels to be reserved for women
- Article 243T(4)- Not less than one-third of the total number of seats to be filled by directed elections in
 every municipality to be reserved for women and such seats to be allotted by rotation to different
 constituencies of a municipality

GOVERNMENT POLICIES AND SCHEME FOR WOMEN EMPOWRMENT⁶

The Government of India launched a National Policy for Empowerment of Women. The specific objectives of the policy are as follows:

- To generate awareness and improve the effectiveness of welfare services meant for women.
- To enjoy all Human Rights as well as Fundamental Freedom by women equally in political, economic, social cultural and civil areas.
- To support and assistance to women affected by violence both in public and private areas.
- Scheme for universalization of women helpline is meant to provide 24hours immediate and emergency response to women affected by violence.
- To provide health care, quality education, carrier guidance, employment, social security, safety etc.
- To abolish discrimination and violence against women
- Changes in social attitudes and community practices by active participation and involvement of both men and women
